

No. G.S.R. 3/Const./Art. 309/2021.— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Service (Executive Branch) Rules, 2008, namely:—

1. These rules may be called the Haryana Civil Service (Executive Branch) Amendment Rules, 2021.
2. In the Haryana Civil Service (Executive Branch) Rules, 2008 (hereinafter called the said rules), in rule 11, in sub-rule (1), under heading "(II) Main Written Examination," against Paper-IV, for existing figure "23", the figure "29" shall be substituted.
3. In the said rules, in ANNEXURE II, for serial numbers 1 to 23 and entries thereagainst, the following serial numbers and entries thereagainst shall be substituted, namely :—

संख्या सांका०नि० 3/संवि०/अनु० 309/2021.— भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवा (कार्यकारी शाखा) नियम, 2008, को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

1. ये नियम हरियाणा सिविल सेवा (कार्यकारी शाखा) संशोधन नियम, 2021, कहे जा सकते हैं।
2. हरियाणा सिविल सेवा (कार्यकारी शाखा) नियम, 2008 (जिन्हें, इसमें, इसके बाद, उक्त नियम कहा गया है) में, नियम 11 में, उपनियम (1) में, "(II) मुख्य लिखित परीक्षा शीर्ष के नीचे, प्रश्न-पत्र IV के सामने, विद्यमान "23" अंकों के स्थान पर, "29" अंक प्रतिस्थापित किये जाएंगे"।
3. उक्त नियमों में, अनुबन्ध II में, क्रम संख्या 1 से 23 तथा उसके सामने विद्यमान् प्रविष्टियों के स्थान पर, निम्नलिखित क्रम संख्या तथा उसके सामने प्रविष्टियाँ प्रतिस्थापित की जाएंगी, अर्थात् :-
