ANNOUNCEMENT

It is hereby announced for the general information of the candidates who have applied for the post of Deputy Director of Horticulture (Class-I) in Horticulture Department, Haryana against Advt. No. 1 (16) of 2018 published on 21.07.2018, that a total of 48 candidates have applied online out of which only 17 candidates have submitted hard copies of their online application forms. After scrutiny of documents, the candidature of all the 17 candidates was found liable for rejection and these candidates were informed accordingly through announcement dated 20.01.2020 with the direction to submit representation, if, any, against their proposed rejection upto 31.01.2020. Against this announcement, only 14 candidates had submitted their representations which were considered by the Commission and only 03 candidates bearing Roll No. 14, 22 & 37 were considered as eligible and rest of the 11 candidates were informed about rejection of their candidature. Against this announcement, two candidates had again represented out of which the candidature of Roll No. 12 was found eligible. Thus total eligible candidates were 04 (Roll No. 12, 14, 22 & 37) and the final rejection were sent to the remaining candidates on 26.05.2021. Further three candidates bearing Roll No. 04, 17 & 45 have been allowed provisionally by the Hon'ble High Court subject to final outcome of CWP Nos. 20328 of 2018, 23668 of 2018 and 24722 of 2018.

Since the number of eligible candidates against 03 posts were less, hence the Commission decided to issue a corrigendum for inviting applications. Accordingly a corrigendum was issued on 21.10.2021 with closing date as on 05.11.2021 with a direction that the candidates who had applied earlier in response to advt. no. 1 (16) of 2018 need not apply again, if they had been found eligible during scrutiny of documents. In response to corrigendum dated 21.10.2021, a total of 20 candidates have applied online out of which 02 candidates were already found eligible against the main advertisement. The scrutiny of documents of the remaining 18 candidates was done and only 05 candidates (Roll No. 53, 55, 58, 62 & 65) were found eligible. All the remaining 13 candidates (Roll No. 49, 50, 51, 52, 54, 56, 57, 59, 60, 61, 63, 64 & 66) were informed about their proposed rejection through email dated 20.12.2021 with a direction that these candidates may submit their representations/appeal against their proposed rejection latest by 27.12.2021. 
